## **Convention on the European Forest Institute**

## Status of Ratification and Entry into Force

The Convention on the European Forest Institute was adopted by the Conference to adopt the Convention on the European Forest Institute and opened for signature by European States and European regional economic integration organizations on 28 August 2003 in Joensuu. In accordance with its Article 14, the Convention remained open for signature in Helsinki at the Ministry for Foreign Affairs of Finland, until 28 November 2003 whereafter the Convention has been open for accession.

The list below contains the latest information concerning dates of signature, ratification/acceptance/approval/accession and entry into force. The column "Ratification/acceptance/approval/accession" indicates the dates when the instrument of ratification (R), acceptance (A), approval (AA) or accession (a) was deposited with the Depositary. The column "Entry into force" indicates the dates of entry into force for respective State or regional economic integration organisation.

The Convention entered into force on 4 September 2005.
